Electoral Violence Cases Recorded on the 2024 Elections

Ghana has successfully conducted eight elections between 1992 and 2020, and peacefully transferred power from one government to the other on three occasions in this Fourth Republic. Electoral violence has been a persistent feature across all eight general elections held in Ghana. The escalated incidents that have been recorded so far from the 2024 General Elections confirm the entrenched nature of electoral violence in Ghana's electoral cycle, posing significant threats to human security. In several instances, properties such as buildings, vehicles, and motorbikes belonging to political parties, the police service, and the Electoral Commission (EC) have been vandalized. More alarmingly, some incidents have resulted in severe atrocities, including serious injuries and loss of lives. The passage of the Vigilantism and Related Offences Act 2019, Act 999; and the National Peace Council's Roadmap to ending political vigilantism have not had any positive impact on electoral violence in Ghana's elections.

In all the eight elections, justice for most of the victims is yet to be served despite persistent calls from various organizations and the public for the justice delivery institutions – (from arrest, investigations, and prosecutions to adjudication), to speed up the process and provide regular information to the public on the status of these cases. There has been little public information and updates on the cases. This seem to corroborate citizens' perception that perpetrators of electoral violence always go unpunished and the victims and their families will be denied justice. Public fears and anxiety regarding justice for victims of electoral violence are understandable, as only a small number of such cases have been successfully prosecuted and concluded over the years.

To support the process in seeking justice for electoral violence victims, the Ghana Center for Democratic Development (CDD-Ghana), in partnership with the West Africa Network for Peacebuilding (WANEP), under the auspices of the National Elections Response Group (NERG) and the Coalition for Domestic Election Observers

(CODEO), launched a post-elections security accountability project in 2021, aimed at supporting justice delivery institutions and aiding victims affected by electoral violence in their pursuit of justice. Although the pilot project ended in February 2022, many cases from the 2020 elections remained unresolved. The 2024 General Elections have also seen a rise in violence and criminal incidents that require the attention of all stakeholders to prioritize and ensure justice for the victims.

We present our findings of the incidents related to the 2024 elections, and also provide an update on the status of our "Post-Elections Security Accountability Project" initiated in 2021 to track major cases recorded from the 2020 elections. Additionally, we will outline our planned collaborative interventions moving forward.

We believe that, by providing data to support advocacy, promoting the swift and efficient adjudication of election-related violence cases, and promoting peaceful co-existence and fostering social cohesion, we can contribute to building a more sustainable and harmonious environment in Ghana.

Methodology

- a. Election Violence Monitoring Desk: CDD-Ghana conducted a desk review of election-related violence cases reported in the media during Ghana's 2024 Presidential and Parliamentary Elections. Each case was meticulously reviewed, with priority given to incidents involving deaths, injuries, and damage to properties. Four Election Conflict Monitoring Desk Officers were trained and stationed at CDD-Ghana to conduct online review of electoral violence cases, and verify from CODEO long-term observers within the various constituencies and regions. Special tracking indicators/checklists were provided for the Desk Officers to guide the information-gathering process. This took place from November 1 to December 6, 2024.
- b. Incident Desk at the CODEO National Information Center: Seventeen volunteers were trained for the Election Day (December 7, 2024) to manage the CODEO Incidents Desk using the online "Appolo system" to track, collate, follow up, and file reports on all the cases that were reported in the system. In addition, three volunteers from the Kofi Annan International Peacekeeping Training Center were also trained and tasked to track all election-related violence cases that were reported in the media. The CODEO Incidents Desk volunteers also worked closely with Penplusbytes, a media and IT organization specializing in information verification and dissemination, dedicated to cross-checking and authenticating gathered information.
- c. Post-elections Violence Monitoring Desk: The four Violence Monitoring Desk

Officers who monitored the pre-election incidents continued their work in the post-election environment and captured all reports after the elections.

Findings

So far, a total of 76 separate incidents have been recorded related to the 2024 elections.

The breakdown:

i. Destruction, seizure, vandalism and invasion of public facilities = 24 cases

For example, ballot papers and pink sheets were destroyed at various Collation Centers. The EC offices in the Damango and Ayensuano Constituencies were set ablaze.

ii. Deaths = 6 cases

For example, at the Nyankpala lorry station in the Tolon Constituency, one **Haruna Shaibu**, a **31-year-old steel bender** was **shot** and **killed** on the spot. A **35-year-old Mukila Ziblim** died from a gunshot wound he sustained from a **stray bullet** in the Damongo Constituency during the collation.

iii. Injuries = 46

These are persons who were identified and treated, with three (3) in critical conditions. For example, the Nyakpala incident left **Abdul Aziz Wunpini** hospitalized, and the Nsawam collation chaos recorded a shooting incident that affected one **Richard Taboh** in the thigh.

Some of the clashes led to serious injuries, and most victims were sent to the hospital for treatment.

The Partners (WANEP and CDD-Ghana on the CODEO and NERG Platform) Plans Going Forward

Follow-Up and Validation of the cases

The CDD-Ghana Security Sector Governance team will follow up in the regions, constituencies and communities where the incidents happened to validate the data we have in our system. The validation process will seek to collect and confirm the details of the cases, including names of the affected people, their locations, and a brief of the story behind each of the cases. The team will engage with the security

officers, the victims and their families at the various locations.

Tracking the cases through the justice delivery chain

A robust tracking mechanism within the justice delivery system will be established to track and update the status of the cases periodically. CODEO volunteers will be trained with a special tracking checklist to follow the cases in the locations and file reports to the CODEO secretariat every month. They will visit the police stations and sit in court proceedings for cases that have been processed for court. The reports will be validated at the national level in collaboration with the Ghana Police Service, and the public will be kept informed through quarterly press briefings.

Victims Platforms

The project will establish a platform for survivors and the families of deceased victims to engage in discussions and explore way forward for their respective cases. This will seek to bridge the gap between investigators and the affected families devoid of suspicion and to canvas citizens' support to aid the investigations. The platforms will also seek to provide updates on the cases and brief the victims and their families of the legal processes being followed to complete the cases.

Action taken by the NESTF on the cases:

- 1. Periodic updates on the incidents
- 2. 132 suspects so far arrested
- 3. 45 remanded in custody
- 4. 71 on police enquiry bail
- 5. 16 on court bail
